

## **Terms and Conditions:**

### ***Disney: The Magic of Animation 'Mickey and Minnie Iconic Places' Competition***

## **Terms and Conditions**

1. By entering this Competition, entrants agree to these Terms and Conditions.
2. "Competition" refers to the *Disney: The Magic of Animation 'Mickey and Minnie Iconic Places' Competition*.
3. The Promoter is Queensland Museum (ABN: 91 522 611 802), Corner Grey and Melbourne Streets, South Brisbane, Queensland 4101 ("Promoter").
4. Queensland Museum is a campus of the Queensland Museum Network.
5. The Walt Disney Company and each of its respective parent, affiliates and subsidiaries are not responsible for the promotion, administration or execution of this Competition.

### **Eligible entrants**

1. Entry is open to residents of Australia who hold an active and public Instagram account and follow @qldmuseum.
2. Employees of the Promoter and their immediate families, directors, management, related companies, and their agencies associated with this promotion are ineligible.
3. If an entrant is under the age of 18 years, the entrant must have permission to enter the Competition from a parent or legal guardian who is 18 years or over.

  - a. Take a photo with a pair of Mickey Mouse or Minnie Mouse Ears in view of an iconic location around Brisbane and/or South East Queensland.
  - b. Upload the photo to their social media account (Facebook or Instagram only) and tag Queensland Museum using the official Queensland Museum hashtag @qldmuseum.
  - c. Ensure their social media account is set to public so that Queensland Museum may view the post.
7. There are no entry limits and all entries become the property of Queensland Museum.
8. The Promoter reserves the right to:

- a. verify the validity of entries;
- b. disqualify an entrant for submitting an entry that is not in accordance with the Conditions of Entry;
- c. accept or reject any entry in its sole discretion.

## **Judging**

9. The winners will be the first five (5) valid entries drawn at random by a representative of Queensland Museum from the pool of entrants.
10. The draw will take place at 9.30am (AEST) Thursday 12 January 2023 at Queensland Museum, Corner Grey and Melbourne Streets, South Brisbane, Queensland 4101.
11. The winners will be notified via Instagram or Facebook direct message and asked to supply their contact details within seven (7) working days of the draw and their details published on the Queensland Museum website. All reasonable attempts will be made to contact the winner.
12. There will be only five (5) winners of this Competition.
13. The judges' decision is final, and no correspondence will be entered into.

## **Prize**

14. Each winner will receive the choice of either:
  - a) one (1) x double pass to Queensland Museum's After Dark on Thursday 19 January 2023.Or:
  - b) one (1) x family pass to Queensland Museum's A Night at the Museum on Friday 20 January 2023.
15. Proof of identification must be presented by the prize winner to collect the prize.
16. The prize is not exchangeable or transferable. If the prize or any part of the prize becomes unavailable for reasons beyond the Promoter's control, the Promoter will endeavour but is not obliged to provide a substitute prize of equivalent value.
