

## ***Jurassic World by Brickman*<sup>®</sup> Competition Terms and Conditions**

1. By entering this promotion, you accept these Terms and Conditions.
2. Instructions and information on how to enter this promotion form part of these Terms and Conditions.
3. The Promoter is the Board of the Queensland Museum (ABN: 91 522 611 802), Corner Grey and Melbourne Streets, South Brisbane ("Promoter").

### **Eligible Entrants**

4. Entry is open to anyone who visits *Jurassic World by Brickman*<sup>®</sup> ("**the Exhibition**") at Queensland Museum, Corner Grey and Melbourne Streets, South Brisbane, Queensland 4101 ("**the Museum**") between Friday 8 December 2023 and Sunday 14 July 2024.
5. Directors, management and employees of the Promoter and their immediate families, directors, management and their immediate families, and any other person or employee of any agency connected with administering this promotion are not eligible. **Immediate family** includes spouse, ex-spouse, de-facto spouse, child or stepchild (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.

### **How To Enter**

8. Entries received outside the Entry Period will not be accepted.
9. To enter, you must, during the Entry Period complete the online entry form, including full name, address, email address, telephone number, using your own smart device to scan the QR code available at the Exhibition.
10. You will receive one entry into the promotion by performing the activities listed in clause 9.
11. You may not enter the promotion more than once.
12. All Entries become the property of the Promoter.

18. The judges' decision in relation to any aspect of the promotion is final, and the Promoter will not enter into any correspondence regarding the result of the promotion.
